The Challenge

The client's platform empowers global enterprises to transform external, unstructured data into reliable, actionable insights—essential for regulatory needs like KYC and anti-money laundering.

Key Challenges

Ingest and manage over 4 TB of complex, commercial data (company ownerships, tax IDs, addresses, and more).

Consolidate and match internal records with external "golden" data sources for maximum integrity and compliance.

Enable advanced, user-friendly search and real-time alerting—all while supporting monthly data refreshes at scale.

Jeavio's Approach

Unconstrained. Fluid. Human.



Unconstrained Thinking	From day one, Jeavio challenged the status quo—choosing to reimagine, not just refactor, the data processing architecture. Our team leveraged distributed computing to build a resilient ingestion pipeline, ensuring future growth would never be bottlenecked by data volume or complexity.
Fluid Execution	With our "shift-left" methodology, we dedicated extensive time up front to discovery and design, surfacing hidden requirements and technical risks early. A full-stack, agile team—ramping from 3 to 12 experts over 15 months—iterated quickly and continuously, delivering a functional MVP in just eight weeks and new capabilities with each sprint.
Human-Centric Collaboration	Jeavio embedded product owners, data engineers, and QA analysts alongside client stakeholders, prioritizing transparency and alignment. Our focus was not only on technical delivery but on making the platform accessible and usable for every user— from compliance teams to business analysts.

Data Engineering at Scale: Ingested, matched, and processed 4+ TB of external and internal data across highly distributed environments.

Advanced Search: Delivered extensive text search and real-time alerting empowering users to surface critical insights instantly. **API-First Platform:** Developed secure, high-performance API access for seamless integration with client workflows.

Agile Transformation: Accelerated local development and streamlined deployment, reducing sprint cycles from three weeks to two.
